| <p><b>Zilker Park And Barton Spring Pool Details</b></p>   |   |
| <ul style="list-style-type: none"> <li>• Barton Springs Pool is open AT ALL TIMES during normal hours. Drive-in access and ADA parking to the pool during road closure times via Mopac and Andrew Zilker on the WEST side of the park, or at the south gate entrance on Robert E. Lee. The southgate parking areas will be closed to all event attendees and staffed by security.</li> <li>• Zilker Park – Rugby Field, Picnic Areas, parking lots, Playscape (South of Barton Springs Road)             <ul style="list-style-type: none"> <li>○ Open to drive in traffic <b>daily</b> until roads close (to allow cars to be removed safely before patrons arise).</li> <li>○ The entire upper area of the Great Lawn will remain open.</li> </ul> </li> <li>• In addition, Auditorium Shores and Butler Park will be open at all times for park users.</li> </ul> |   |
| <p><b>Neighborhood Patrol - Dedicated Neighborhood ROVING Patrol</b></p>   |   |
| <p>4 officers and 1 sergeant - Roving 5 pm until approximately 10 pm daily. This dedicated unit will be roving and responding to issues/concerns throughout the impacted neighborhoods.</p>  |   |
| <p><b>General Violations</b> Examples of what to call in....</p>   |   |
| <ul style="list-style-type: none"> <li>○ Parking within 30' of the approach to a stop sign.</li> <li>○ Parking or blocking within <b>15' of a fire hydrant.</b></li> <li>○ Parking left wheel to curb. (cars parked facing against traffic).</li> <li>○ If a car blocks <b>YOUR</b> driveway. Some neighbors may permit people to block their OWN driveway.</li> <li>○ Illegal vending/sales questions in the immediate festival area.</li> </ul>  |   |
| <p><b>Helpful Neighborhood Reminders</b></p>   | <ul style="list-style-type: none"> <li>• Please don't put barriers in the street. They will be removed.</li> <li>• Restricted parking areas are prohibited parking areas for all persons.</li> <li>• Immobilized cars should be moved out of restricted parking areas.</li> </ul>                                       |
